**1. During the Promotion Period, eligible entrants may enter the Promotion by following one of the below entry methods. Completion of all the steps in either entry method results in an “Entry.”

- iii. Each eligible purchase made while properly authenticated to the your Loyalty Account will automatically generate one (1) Entry.
